Administration Details

Trans-Vaal Zimbabwe & Botswana Association is a registered charity, the registered office and charity number is shown on page 1

Structure, Governance and Management

Trans-Vaal Zimbabwe & Botswana Association is governed by a constitution adopted on 16 October 1935, and amended 29 June 1967.

Organisation

The Charity is administered by the Trustees as listed on page 1. The Trustees meet at least one a year. They are satisfied with the results for the year, the level of reserves and the ability of the Charity to meet its liabilities when they fall due.

Public Benefit

The Trustees confirm that they have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the Trust's aims and objectives and in planning future activities.

Financial review

The Trustees were frustrated with the activities during the year but the position at the year end was acceptable. The Trustees had a difficult year due to the COVID19 pandemic. Activities that were planned had to be cancelled. Grants of £300 were awarded to all dioceses to help with COVID 19.

However, an excess of £5,301 has increased the funds carried forward to 2021 and the total funds were £193,670 meaning that the trustees are confident that the Charity can meet its liabilities whenever they fall due.

Restricted and Unrestricted Funds

Notes 3 to 5 show the breakdown of the funds held per the Statement of Affairs between balances available for distribution and those not available for distribution. These latter are gifts and bequests which are generally earmarked for a particular project or diocese and on which a restriction has been placed either by the donor or by the Association. These monies are invested and the income then distributed to the relevant diocese or project or to TZABA's general fund.

Note 4 shows the balances earmarked as available for distribution by the Association and the movement in balances held from the start of the year to the end. These movements are shown on page 4 & 6 through the sums received by each diocese and the general fund during the year and the amounts remitted to the diocese. The source of this income is largely shown in notes 6 to 13 of the accounts on page 7.
